

Guideline for Submitting Proceeding to the 14th International Symposium of the Protein Society of Thailand (PST 2019)

Important notes to corresponding author

The corresponding author is required to complete and sign the copyright transfer form, and submit it via the on-line conference management system along with your proceeding.

General information for preparation of proceeding

| Page layout | A4 page, in a portrait orientation, single column, leave 1-inch margins at the top and bottom, and 1.25-inch margins on the left and right sides |
| Font | Times New Roman, 12 points, regular, unless stated otherwise Single-spaced throughout the text |
| Paragraph | Justified to both sides, no indentation, leave a line between paragraphs, unless stated otherwise |
| Headings | Abstract, Keywords, Introduction, Experimental, Results, Discussion, Conclusion, Acknowledgements, and References Use Times New Roman, 12 points, bold, justified to both sides. Do not leave a line between the headings and the following text |
| Abbreviations | Spelled out, in parenthesis, in the first use in the text. |
| Unit | SI system |
| Reference style | In the text, indicate references by number(s) in square brackets, in the order of their appearance in the text, in line with the text (e.g. [1], [3,5], etc.). |
| File format | Microsoft word 97-2003 |
| File size | No larger than 1 MB |
| Submission | Via the on-line conference management system (www.proteinsocthai.net/symposium/2019/user_login.php) by May 20, 2019 extended to May 31, 2019 . Hard copies will not be accepted. |
| Notifications | by June 15, 2019 . |

Title and affiliations

| Title | Full title (be concise) using Times New Roman, 14 points, bold, centered The first word and proper nouns in the title should be capitalized. Do not use abbreviations and acronyms in titles. |
| Author(s) | Full name(s) using Times New Roman, 12 points, regular, centered Indicate all affiliations with a lower-case superscript letter immediately after the author's name and in front of the appropriate address Indicate presenting author with underline Indicate corresponding author(s) with * after the name |
| Affiliation(s) | Indicate Department/Division, University/Institute, City, Postcode, Country, using Times New Roman, 11 points, italic, and centered, immediately after the appropriate superscript letters. |
| Email | Only that of the corresponding author(s), using Times New Roman, 11 points, italic, centered |

Abstract

Abstract should not exceed 250 words. Describe briefly the purpose of the research, the principal results and major conclusions. References should be avoided.

Keywords: Up to 4 keywords identifying the nature of the subject matter, listed alphabetically and separated by comma

Introduction

The introduction should be as concise as possible, without subheadings. The introduction should provide an adequate background, and the importance and the objectives of the work.

Experimental

Provide sufficient detail so work can be repeated. Describe new methods in detail; accepted methods briefly with references. Use subheadings (Times New Roman, 12 points, italic, justified

to both sides) as needed for clarity, but do not leave a line between the subheadings and the following text.

Results

Present results concisely using figures and tables as needed. Do not present the same information in both figures and tables. Use subheadings (Times New Roman, 12 points, italic, justified to both sides) as needed for clarity

Discussion

Interpret the results. Discuss principles and relationship. Point out exception. Show agreement/disagreement with published research work. A combined Results and Discussion section is often appropriate.

Conclusion

Describe the conceptions and/or the significance of the work.

Acknowledgements

Provide the names of those who have providing help during the research (including funding agencies).

References

List only those references cited in the text (numbers in square brackets) in the order of their appearance. References should be written in Times New Roman, 11 points, Vancouver (brackets) style, justified to both sides with 0.38-inch hanging.

Figures

Figures should be numbered consecutively in the order of their appearance in the text with Arabic numerals (i.e. Figure 1, Figure 2, etc.). The Figure titles should be written in Times New Roman, 12 points, bold, justified to both sides, and placed below the figures. Figure descriptions should be written in Times New Roman, 12 points, and regular, justified to both sides, and placed after the title.

High quality figure(s) of at least 300 dpi are preferred. Lettering, data lines and symbols must be sufficiently large so as to be clearly visible when the figure is reduced to an A4-sized page. All figures will be reproduced in grayscale only.

Authors are responsible for obtaining permission to reproduce previously copyrighted illustrations. Proof or certification of permission to reproduce is required.

Tables

Tables should be numbered consecutively in the order of their appearance in the text with Arabic numerals (i.e. Table 1, Table 2, etc.). The Figure titles should be written in Times New Roman, 12 points, bold, justified to both sides, and placed above the tables. Footnotes should be identified by a lower-case superscript letter in the body of the table, written in Times New Roman, 12 points, regular, justified to both sides, and placed below the table.
